The laboratory examination result of faecal occult blood is **positive**.

# **OPINION**

Our laboratory examined both submitted stool samples. We would like to let you know that the laboratory examination result of faecal occult blood in your faeces is positive.

A positive examination result of faecal occult blood means that your stool samples include traces of blood. This does not mean that you have colorectal cancer. The majority of people with a positive result do not have cancer. The result is just an indicator of changes going on in your intestines that are causing bleeding and require further examination. To determine the cause of bleeding we need to check your large intestine. Colonoscopy is the most suitable form of examination. There is more information about colonoscopy and how to prepare for it in the enclosed material.

We have also informed your GP about the result. **Please note that you must visit your physician in the next 7 days with this result and all accompanying documents.** Your physician will check you and determine if you have medical issues which could prevent us from carrying out a detailed large intestine check. If your medical condition allows us to carry out the examination, your physician will:

- Fill out a referral for a SVIT screening colonoscopy;
- Write a **prescription** for the Moviprep<sup>®</sup> bowel cleansing medication (that you will be given in the pharmacy free of charge);
- Help you fill out the enclosed **questionnaire** which you will give to a colonoscopy specialist;
- Provide all necessary instructions about taking drugs which influence colonoscopy if you happen to take them (these also include diabetes and blood-thinning medications);
- Provide previous colonoscopy results or other results which could influence the examination or other medicinal documentation at his/her own discretion.

Please call us on 01/620 45 22 immediately after visiting your physician from Monday to Friday between 9AM and 2PM to arrange a time and place for a colonoscopy which suits you best. You can also send us an e-mail at svit@nijz.si or a fax to 01/620 45 29. You will then receive an appointment with an exact date, time and place of examination by post.

Please call us even if your physician decides that colonoscopy is currently not recommended for you because of your medical condition.
